### 1 Estimates, Expenses and Payment terms

The estimate overleaf sets out the services we agree to supply. This estimate is an indication of the charges likely to be incurred on the basis of the information and details we know at the date of the estimate, the charges are liable to alteration particularly where third parties change their rates or charges. A deposit of £1,200 is payable within two days of the date of this estimate and will be applied at our discretion.

We may not know the amount of third party charges in advance of the funeral; however, we give the best estimate of such charges in the written estimate. The actual amount of the charges will be detailed and shown in the final account.

If you amend your instructions we will require your written confirmation of the changes. We may need to make an extra charge in accordance with prices published in our current price lists.

We will add VAT to our charges, where applicable, and at the rate applicable when we prepare the invoice.

Payment terms are 14 days from date of invoice. Cheques payable to Radcliffe Funeral Service or by bank transfer, details available on request. We reserve the right to charge interest on any amount outstanding 3 months after the funeral date. Interest charged monthly or part of at 4% over base rate.

Direct cremation to be paid in full 48 hours after the date on this estimate.
